Abuse Prevention Training

Youth for Christ USA requires that all volunteers within the organization who work with youth complete Abuse Prevention Training. You will be required to complete this training if you are going to volunteer with our ministry. The training that must be completed is available to you as **two, brief online videos**. This training must be completed before you can interact with youth or attend any YFC outings with the youth. More information on this training will be sent to you by YFC Administration upon submission of your volunteer application.

Proof of Auto Insurance

YFC maintains high standards for staff and volunteers driving kids on behalf of the ministry. YFC will be selective in determining who will transport kids, insisting on minimum standards for age, driving record, and personal insurance levels. To transport kids in their personal vehicles, drivers must have current insurance that meets the minimum required \$300,000 aggregate, \$100,000 per accident limits. A copy of your current valid insurance declaration page will be kept on file in the YFC office.
